<u>Development Committee Update</u>- Julian gave an update to the board on the letter MOSI received from Hillsborough County regarding the "Seminole Gaming Compact". <u>Consultant Proposal-MOSI Strategic Planning-</u> A copy of consultant proposals were provided to the Board for their review and consideration. The Finance Committee has recommended that the Board make a motion to approve the current FY budget, and empower the Executive Committee to approve the budget.
